In accordance with 23 CFR Section 771.119 and Section 771.121, the Texas Department of Transportation (TxDOT) and Federal Highway Administration (FHWA) has determined that the I-35 Capital Express North project from SH 45N to US 290E will not have a significant impact on the human or natural environment.

This Finding of No Significant Impact (FONSI) for the Preferred Alternative is based on the final Environmental Assessment (EA) dated December 2021 and the entire project record. This decision documents the selection of the Build Alternative, presented in the final EA as the Preferred Alternative, which is described as:

The I-35 Capital Express North project from SH 45N to US 290E would add one non-tolled managed lane in each direction, reconstruct intersections and bridges to accommodate the additional lane and increase east/west mobility, reconstruct the Wells Branch Parkway interchange to a diverging diamond intersection (DDI), change ramp configurations to accommodate proposed mainlane improvements and improve traffic operations, and improve bicycle and pedestrian accommodations along I-35 frontage roads and at east/west crossings. The project length is approximately 11.5 miles. The project would require approximately 17.0 acres of additional ROW, 0.2 acre of proposed permanent drainage easement, and 3.3 acres of proposed driveway license areas to implement. The purpose of the proposed project is to be consistent with local plans, reduce congestion, and improve mobility and safety on I-35 between SH 45N and US 290E.

A Notice of Availability of the draft EA was issued on April 19, 2021.

A virtual public hearing for this project was posted on May 10, 2021, with an in-person option on May 10, 2021.

No changes to the draft EA were made as a result of comments received on the draft EA during the posted comment period or from comments made at the public hearing.

Public Hearing Documentation has been prepared and is available for review on request.

The final EA and reports contained in the file of record have been independently evaluated by TxDOT and determined to adequately and accurately discuss the need, purpose, alternatives, environmental issues, impacts of the proposed project, and appropriate mitigation measures. These documents provide sufficient evidence and analysis for determining that preparation of an Environmental Impact Statement is not required. These documents are incorporated by reference into this decisional document.

Based upon TxDOT's review and consideration of the analysis and evaluation contained in the EA for this project, and after careful consideration of all social, economic, and environmental factors, including input from the public involvement process, TxDOT hereby issues this Finding of No Significant Impact for the I-35 Capital Express North project from SH 45N to US 290E.
